Two files: One entitled "Before the Rebellion of 1917; the other - "After the Rebellion of 1917 & 1918. Both of these files contain many onion-skin copies of letters to Rutherford from Van Amburgh, Macmillian, and other people. Also, copies of letters Rutherford wrote the brothers from prison and elsewhere.

Copies of meeting minutes from the time when Rutherford was in prison and when he was released. Also, the "Testimony of W. E. Spill at a meeting of the Board of Directors of the WTB&TS, held in the offices of the Society at 310 Martin Building, Pittsburgh, PA., July 30, 1919." Both files contain information about the early workings of the organization and the rebellion in 1917, etc.

A few of the letters in the back of the file labeled "Before Rebellion of 1917" are dated 1916 and addressed to C. T. Russell. Also in the back of this file is the letter Macmillian read to the Bethel family when Russell died, and the announcement to the Bethel Family as to who would fill the vacancy on Board of Director.
