## SUMMARY OF ORAL INFORMATION PRESENTED TO LOCAL BOARD NO 22 DECEMBER 3, 1957 BY RICHARD M. RAWE 45-22-34-183

The purpose of a personal appearance as defined by Section 1624.2 (b) is to discuss my classification, point out classes I think I should be placed in, direct attention to information the board may have overlooked an present more information.

Class IV-D, I feel, is my proper classification. Ifeel the board has declined to give me IV-D because: (1) It has not given sufficent consideration to Section 16 (g) of the Act and 1622.43 (a) and (b) of the Regulations. (2) It has failed to give enough weight to the evidence I have submitted showing I measure up to the requirements of the Act and Regulations in order to receive a IV-D. (3) The Board has set up artificial standards in place of the ones required by the Act and Regulations.

These points were discussed in my letter dater October 17, 1957 which is in the file. I now wish to discuss these points with the board, to impress their importance upon the board.

Concerning the November 5, 1957 summary of the Board I note that the Board recognizes that I have a congregation, but then goes on to set up artificial standards for a Minister under the Act and Regulations. It says: "That the registrant's congregation is an area congregation with no central meeting place, no office, no set time or place for gegular meetings and generally no structure could be recognized". First of all let it be noted that no such requirements are made by the Act or Regulations. Second, I have testified that my congregation dose have a central place of meeting and regular meetings. My 'Summary' of August 8, 1955 and the September 30, 1957 "To Whom It May Concern:" show this. I want to testify now that I have two offices, one at Grand Coulee and one in Lakeview Park at which I can be reached by phone or letter as well as in person by members of my

congregation or others. For your benefit I wish to cutline the structure of my congregation a little more. I give personal instructions to members of my congregation in a regularly conducted home Bible study, by answering Bible questions, giving spiritual guidance, etc. Members of my congregation also attend regularly scheduled meetings at the Kingdom Hall and elsewhere to study the Bible collectively and to here me give sermons. Moreover, as members of my congregation progress I give them personal training in the Public Ministry. Train them to be ministers like myself.

Reference is also made to "Amended Minutes of Local Board Meeting of January 5, 1954". Here the objection was made that I was not a "leader" DIDN and that my induction would not "leave a congregation without a cleric". So that the leader of my congregation and my induction would confidence in my August 8, 1955 'Summary' and my October 17, 1957 letter and in this document. I want to review these for your benefit on this point.
